1. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Okinawa Karate LLC, or the employees, representatives or agents of Okinawa Karate LLC.
2. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Okinawa Karate LLC for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Okinawa Karate LLC, whether caused by the fault of myself, my family, Okinawa Karate LLC or other third parties.
